#### **Assignment Title: Development of Legal and Institutional Infrastructure for Piloting an ETS**

**Reference No.** (as per Procurement Plan): PMR-TRII-C1-CS1

The Ministry of Environment and Urbanization of Turkey has received financing from the World Bank for the “Partnership for Market Readiness Turkey Project- Phase II” and intends to apply part of the proceeds for consulting services.

The consulting services (“the Services”) include assisting the Ministry to prepare the technical foundations of a draft climate change law and ETS regulation including primary and secondary legislation and institutional requirement towards establishing a pilot scheme in Turkey. The outputs of the assignment will provide the MoEU with a robust guidance and infrastructure to further and finalize the preparations of legal and institutional underpinnings for piloting an ETS.

The scope of Services is summarized below:

- Review of the Turkish Legal and Institutional System and Gap Analysis
- Analysis of the Selected Climate Change Laws and ETS Regulations Globally
- Development of Draft Climate Change Law for Turkey and Draft ETS Regulation through a consultative process
- Compatibility and Interaction Analysis
- Organization of extensive stakeholder feedback meetings.

The assignment is expected to start in March 2019 and will last 14 months. The last 2 months are reserved for translation, proof-reading and editing of the outputs.

The detailed Terms of Reference (TOR) for the assignment will be shared with the successful Consultant only.

The Ministry of Environment and Urbanization of Turkey now invites eligible consulting firms (“Consultants”) to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services.

The shortlisting criteria are:

- Experience in advising high-level policy makers, ministries and private sector in terms of establishment and design of emission trading schemes, including building the legal framework, taxation and capital markets;
- International experience on drafting climate related legislation and local experience in working through the legislative processes.
- Local experience on Turkish legislation including on fiscal, taxation, and capital markets regulations.
- Experience demonstrating a good understanding of climate change legislation, as well as cap and trade schemes;
- Experience in designing, facilitating and leading interactive workshops and stakeholder meetings on ETS;
- Experience in emission reduction policy development in heavy industry; and,
- Staffing capacity on the above requirements.

Consultants are expected to provide information on the list and positions of their staff that participated in the previous similar assignments completed.

The attention of interested Consultants is drawn to Section III, paragraphs, 3.14, 3.16, and 3.17 of the World Bank's "Procurement Regulations for IPF Borrowers" July 2016, setting forth the World Bank's policy on conflict of interest.

Consultants may associate with other firms to enhance their qualifications, but should indicate clearly whether the association is in the form of a joint venture and/or a sub-consultancy. In the case of a joint venture, all the partners in the joint venture shall be jointly and severally liable for the entire contract, if selected. Interested consultants should clearly indicate the structure of their "association" and the duties of the partners and sub consultants in their application. Unclear expression of interests in terms of "in association with" and/or "in affiliation with" and etc. may not be considered for short listing.

A Consultant will be selected in accordance with the Consultants' Qualifications (CQS) method set out in the Procurement Regulations.
