



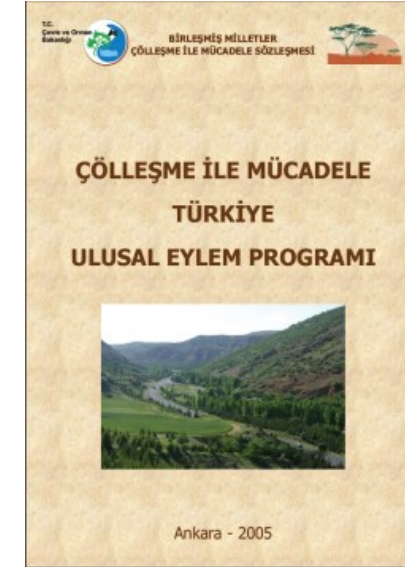

**National Strategy and Action Plan to Combat  
Desertification (ÇMUSEP) Monitoring, Evaluation  
and Reporting System (IDRS)**



- The United Nations Convention to Combat Desertification (UNCCD) was signed in 1994 and our country officially became a party to it in 1998. According to the Convention, the Parties are obliged to prepare National Action Plans.
- The National Action Plan to Combat Desertification was prepared in 2005.
- In 2007, the 10-Year Strategic Plan to Combat Desertification (2008-2018) was adopted by the UN.
- The 2015 Strategy Document and Action Plan were combined to form the “National Strategy and Action Plan to Combat Desertification” as a single document.

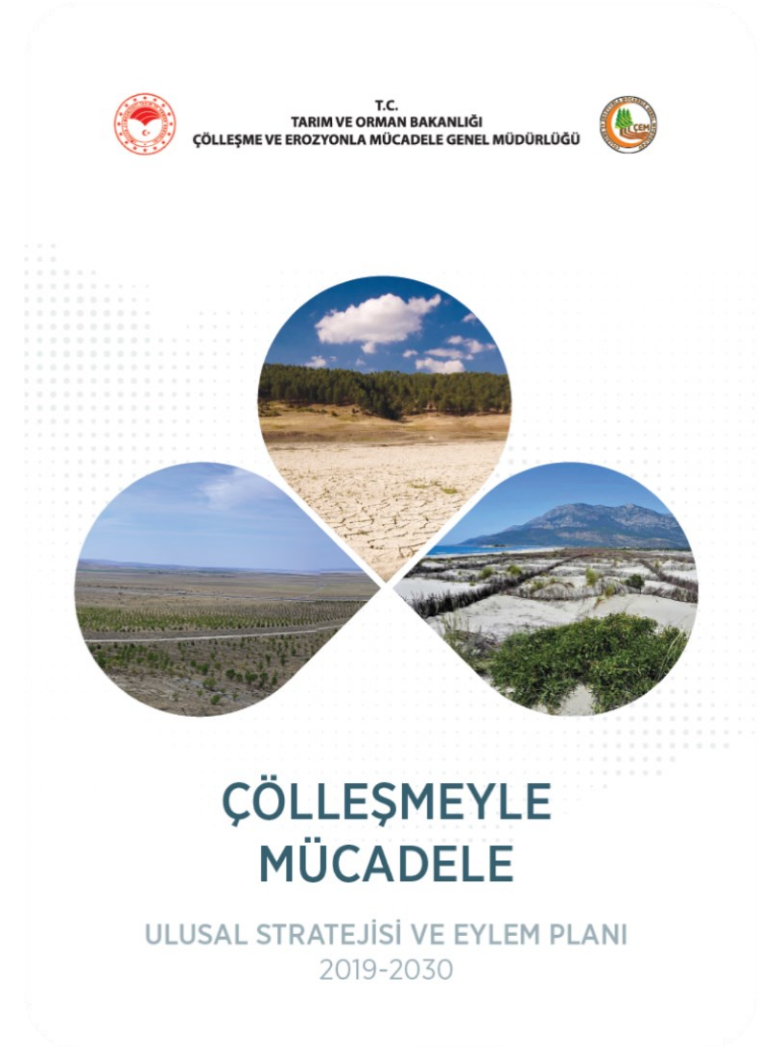

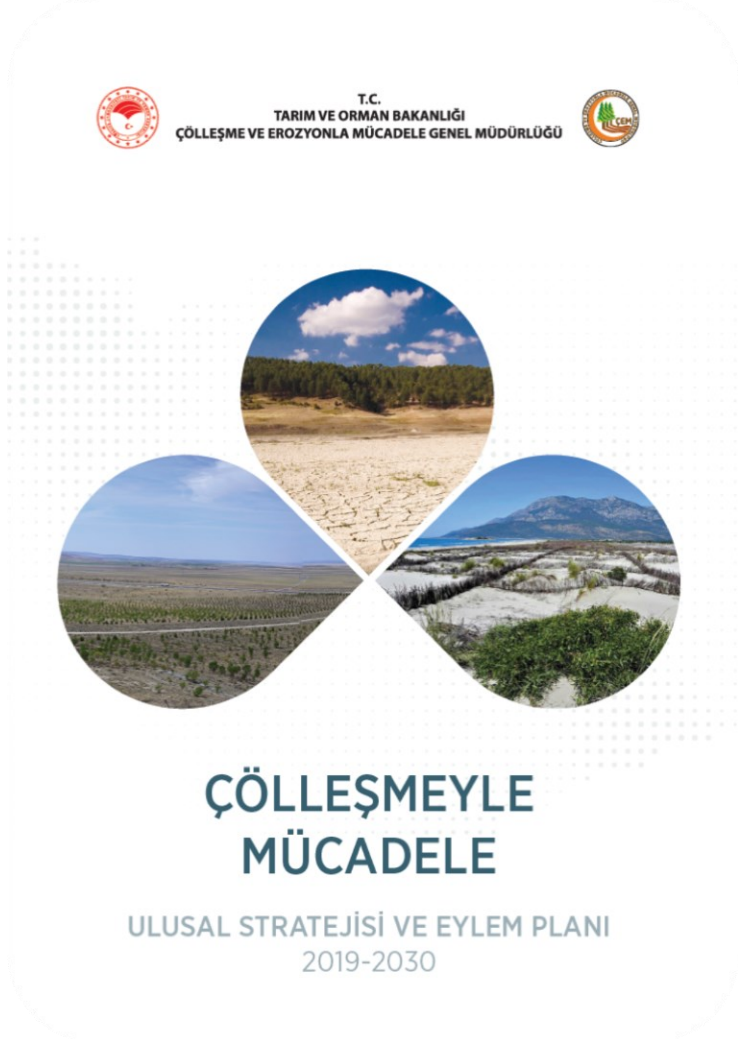

### Strategic Objective 1

To improve the conditions of affected and potentially affected ecosystems, combat desertification/land degradation, promote sustainable land management and contribute to Land Degradation Neutrality (LDN),

### Strategic Objective 2

To improve the living conditions of the affected and potentially affected population,

### Strategic Objective 3

Mitigate, adapt to and manage the impacts of drought to increase the resilience of vulnerable populations and ecosystems.

### Strategic Objective 4

Contributing to the provision of global benefits through the effective implementation of the UNCCD.

### Strategic Objective 5

Mobilizing the necessary financial/non-financial resources to support the implementation of the agreement by establishing an effective partnership between national and international actors; leading Turkey in bilateral, regional and global cooperation in this direction, sharing its knowledge and experience with other parties,



### National Strategy and Action Plan to Combat Desertification (2024-2030)

The work to update the National Strategy and Action Plan began at the end of 2023. The draft document is still being worked on, and changes, updates and additions are made, and the strategy and action plan are planned to be finalized in 2024.







## ÇMUSEP MONITORING EVALUATION REPORTING SYSTEM (IDRS)

It is a web-based monitoring, evaluation and reporting system for effective online collection and reporting of desertification combat activities. (<http://cmusep.cevre.gov.tr>)

Within the scope of the Action Plan, institutions have been reporting regularly through the system every year since 2015.

■ Reporting was made with the PRAIS4 system in 2022 and the next reporting will be made in 2026.
