The Ministry of Environment, Urbanization and Climate Change has received financing from the Japan International Cooperation Agency (JICA) toward the cost of the Emergency Earthquake Disaster Reconstruction Project (EEDRP) and intends to apply part of the proceeds for consulting services.

General Directorate of Construction Affairs (GDCA) of The Ministry of Environment, Urbanization and Climate Change (MoEUCC) will serve as the main implementing agency for the Project. The overall objective of the Project is to stabilize the lives of residents in Southeastern Türkiye earthquake affected, by reconstructing disaster and climate resilient and energy efficient rural housing and village infrastructure, thereby improving the socio-economic growth in the areas.

The consulting service (“the Services”) includes the hiring of a full-time **Financial Expert** (TERRP/INDV-FE-02) to support the GDCA's Project Implementation Unit. The selected consultant is expected to be awarded with a one-year renewable contract.

Consultants will be selected in accordance with the Applicable Guidelines and JICA’s Guidelines for Procurement under Japanese ODA Loans.

The General Directorate of Construction Affairs now invites eligible individual consultants (“Consultants”) to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services.

The contract will be signed between the General Directorate of Construction Affairs of MoEUCC and the consultant. Expressions of interest (CVs) in Turkish and English together with one-page application letter must be delivered to the address below in person or by e-mail, indicating the title and the reference code for the applied position in the subject line. The deadline for application is **December 10, 2024; at 4:00 p.m. (Türkiye Local-Time)**.
