The Ministry of Environment and Urbanization has received financing from the the Government of Japan (hereinafter referred to as the “GoJ”) towards the Emergency Earthquake Disaster Reconstruction project and intends to apply part of the proceeds for consulting services.

General Directorate of Construction Affairs (GDCA) of The Ministry of Environment, Urbanization and Climate Change (MoEUCC) will serve as the main implementing agency for the Project. The overall objective of the Project is to stabilize the lives of residents in Southeastern Türkiye earthquake affected, by reconstructing disaster and climate resilient and energy efficient rural housing and village infrastructure, thereby improving the socio -economic growth in the areas.

The consulting service (“the Services”) includes the hiring of a full-time Procurement Expert to support the GDCA's Project Implementation Unit. The selected consultant is expected to be awarded with a one-year renewable contract.

Consultants will be selected in accordance with the Applicable Guidelines and JICA’s Guidelines for Procurement under Japanese ODA Loans.
