

#### ✓ Name of the parent company

A parent company is a company that owns or controls the company operating the facility (for example by holding more than 50% of the company's share capital or a majority of voting rights of the shareholders or associates).

#### ✓ Name of the facility

This is the usual name of the facility.

#### ✓ Identification number of facility – Any Ideas from previous Experiences?

This is a unique number for the facility. It will be provided to the operator by the Ministry upon submission of the completed inventory.

The unique identification number should then be used on all future reporting.









- ✓ Street address
- ✓ Town / village
- ✓ Postal code
- ✓ Country
- ✓ Coordinates of the location Any obligatory Coordinate System by MoEU?

The co-ordinates of the location should be expressed in longitude and latitude coordinates giving a precision of the order of at least  $\pm$  500 meters and referring to the geographical centre of the site of the facility.

#### ✓ River basin district

#### ✓ NACE-code (4 digits)

The NACE-code in 4 digits according to Commission Regulation 29/2002/EC of 19 December 2001 amending Council Regulation (EEC) No 3037/90 on the statistical classification of economic activities in the European Community.

#### ✓ Main economic activity

The main activity carried out by the facility should be specified. This is the designation of the main economic activity in words according to the NACE-code. For example:

Example 1: Manufacture of basic chemicals

Example 2: Collection and treatment of other waste

Example 3: Sewage and refuse disposal, sanitation and similar activities

### How to fill Table?

- ✓ *Production volume (optional) & Number of installations (optional)*
- Number of operating hours in year (optional) & Number of employees (optional)
- Text field for textual information or website address delivered by facility or parent company (optional)
- a link to a website which shows the environmental report or the EMAS statement of the facility or the parent company;
- information on changes in the history of the facility (closure, relocation, severance or merger of facilities) for the last 10 years which might have also resulted in a change of the identification number of the facility in order to enable reasonable comparisons between different reporting years unless the information is already available to the competent authority;
- explanations for changes in reported releases and transfers;
- information on the type of fuel used in the case of Large Combustion Plants;
- an e-mail address for public enquiries directly to the facility;
- information on non-Annex I activities that have been included in reporting;
- permit conditions.









- ✓ Production volume (optional)
- ✓ Number of installations (optional)
- ✓ Number of operating hours in year (optional)
- ✓ Number of employees (optional)
- ✓ Text field for textual information or website address delivered by facility or parent company (optional)
- ✓ Coding of activities and identification of the main Annex I activity

All E-PRTR Regulation Annex I activities carried out at the facility have to be listed according to the coding system given in Annex I and, (if available), the IPPC code (now the IED). The E-PRTR code consists of a number from 1 and 9 and a letter from a to g. For some activities, there is a further sub-division from (i) to (xi).
