The Ministry of Environment, Urbanization and Climate Change has applied for financing from the World Bank toward the cost of the Public and Municipal Renewable Energy Efficiency Project (PUMREP) and intends to apply part of the proceeds for consulting services.

General Directorate of Construction Affairs (GDCA) of The Ministry of Environment Urbanization and Climate Change (MoEUCC) will serve as the main implementing agency for the Component 1, 3a and 4a of the project. The overall objective of the Project is to increase the use of renewable energy (RE) through self-generation in public facilities. The implementation period for the project is 5 years.

The consulting service (“the Services”) includes the hiring of a full-time **Solar Energy Expert** (PUMREP/WB/IND-SOE-01) to support the GDCA's Project Implementation Unit. The selected consultant is expected to be awarded with a one-year renewable contract.

The General Directorate of Construction Affairs now invites eligible individual consultants (“Consultants”) to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services.
