The Ministry of Environment and Urbanization has received financing from the World Bank for the cost of the Seismic Resilience and Energy Efficiency in Public Buildings Project (SREEPB) and intends to apply part of the proceeds for consulting services.

General Directorate of Construction Affairs (GDCA) of The Ministry of Environment Urbanization and Climate Change (MoEUCC) will serve as the main implementing agency for the Project.
